Application Conditions

- The City of Muskegon, its agents, and/or employees shall not be liable either jointly or separately for damage to persons or
 property while the same are within the geographical limits of Harbour Towne Beach, or adjacent/nearby City of Muskegon
 mooring and Department of Public Works/Leisure Services boat and trailer storage areas, occasioned by fire, explosion, theft,
 collision, acts of God, or any other cause.
- The City of Muskegon shall have a lien of the above-described boat for any unpaid fees or storage charges under the terms of this agreement, and the City of Muskegon shall have the right to possess of said boat and to dispose of the same and to satisfy any unpaid storage fees or changes in accordance with the provisions of applicable governmental laws.
- 3. The applicant shall remove the boat and all associated trailers, dinghies, and gear in the ownership of the applicant or cause the same to be removed from Harbour Towne Beach/Pere Marquette, or adjacent/nearby City of Muskegon mooring and Department of Public Works/Leisure Services boat and trailer storage areas within fifteen days after the expiration of this agreement. Applicant will be assessed reasonable rental an any special charges or costs incurred by the City of Muskegon as a result of failure of the applicant to remove the boat and associated equipment from said areas within said fifteen days. The City of Muskegon shall have the lien upon the above-described boat for these charges; the lien to be enforced in the manner prescribed in paragraph 3. Above.
- 4. The City of Muskegon, through its agent, shall have the right to terminate this agreement at any time, without cause, by giving the applicant twenty-four (24) hour notice, in writing prior to such termination. No refunds shall be made if the termination of this agreement is due to applicant's violation of any applicable rules and regulation or failure to comply with any of the conditions stipulated herein.
- 5. Ownership of any watercraft docked under the permit granted through this application will be assumed and accepted by the undersigned applicant as owner of agent of the owner.
- 6. Falsification in completing any portion of the application can lead to immediate cancellation of the permit.
- 7. Deposits are non-refundable
